

TERMS AND CONDITIONS FOR SCHOOL FEES (2026–2027)

International School Eindhoven (ISE) / Stichting SILFO

1. FEES AND CONTRIBUTIONS

1.1 School Fees and Voluntary Parental Contribution

The school fees and voluntary parental contribution for the 2026–2027 academic year are as follows:

- Primary International Department: € 6,690 per student / year
- Secondary International Department: per student / year
 - MYP 1 – MYP 4: € 8,569
 - MYP 5: € 8,700
 - DP 1: € 8,951
 - DP 2: € 9,466
- Primary Dutch Bilingual Department (Voluntary Parental Contribution): € 2,499 per student / year

Legal Provision (Voluntary Contribution): In accordance with Article 40 of the Dutch Primary Education Act (*Wet op het primair onderwijs - WPO*), the parental contribution for the Dutch Bilingual Department is voluntary (*vrijwillige ouderbijdrage*). Schools are permitted to ask parents for a contribution towards costs. The conditions are that this contribution is voluntary and that the parents on the Participation Council (MR) have approved it. The purpose of the voluntary parental contribution is to fund a number of matters that are not, or not sufficiently, covered by the government funding. At the ISE, this includes small class sizes, extra teaching assistants, support with acquiring another language, support for learning and developmental difficulties, various extracurricular activities, school camps, school trips, and curriculum-related visits. These facilities are necessary to maintain the high quality of our education and to provide your child with memorable experiences that will be cherished long after they leave the school. If you choose not to pay the voluntary parental contribution, this will not affect the student's admission, enrollment, or full participation in any curriculum or school activity.

1.2 Application Processing Fee (applicable to the Primary and Secondary International Departments only)

An administrative application fee of € 200 per student applies to all submitted applications and is non-refundable, except during the statutory 14-day cooling-off period (*bedenktijd*) following payment, as provided under Dutch consumer protection law.

- **Validity Period:** Payment of the application fee remains valid for one (1) calendar year from the date of receipt. If enrollment does not take place within one year of payment, the application expires, and a new application fee must be paid to maintain or reactivate the application.

- **Re-application Exception for Withdrawn Students:** If a student withdraws from ISE and the family re-applies within one (1) calendar year of the official withdrawal date, the application fee is waived.

1.3 Refundable Secondary Security Deposit

A one-time, interest-free deposit of € 500 per student is invoiced upon entry into the Secondary International Department.

- This amount will be refunded upon the student's final departure from the school, provided that:
 1. All school-owned books, digital devices, and educational materials are returned undamaged and in good condition.
 2. The locker key is returned.
 3. All outstanding fee invoices and financial balances are settled in full.
 4. All contractual withdrawal requirements have been satisfied.
- If any obligations remain unmet, ISE reserves the right to set off outstanding costs against the deposit balance.

1.4 Accepted Payment Methods

An invoice will be issued for all fees. Payments must be executed via direct electronic bank transfer or SEPA Direct Debit. Cash and credit card payments are strictly not accepted.

1.5 Sibling Policy

School fees, application fees, and deposits apply per individual student. No discounts are offered for siblings attending the school concurrently.

1.6 Billing Policy for Divorced or Separated Parents

The school issues one single invoice per student addressed to the primary billing contact designated during enrollment.

- **No Split Invoicing:** The school does not divide school fee invoices between divorced or separated parents, nor does it engage in private cost-sharing agreements (*ouderschapsplan*) established between parents.
- **Joint Liability:** Under Dutch contract law, both parents or guardians with parental authority (*gezamenlijk gezag*) or signatories to the enrollment agreement remain jointly and severally liable (*hoofdelijk aansprakelijk*) for the full payment of all invoiced fees.

2. PAYMENT TERMS AND SCHEDULES

An official invoice will be issued for all school fees. Parents/guardians may select one of the following payment terms:

2.1 One Time Payment (1 Instalment)

The full annual invoiced amount must be transferred in one payment within thirty (30) calendar days from the invoice date.

2.2 Payment in Ten (10) Instalments (SEPA Direct Debit)

Parents may opt to pay the school fee / voluntary parental contribution in ten (10) monthly instalments running from September 2026 to June 2027.

- This option requires the completion and execution of a SEPA Direct Debit Authorization Form.
- The exact instalment amounts and deduction dates will be explicitly detailed on the issued invoice.
- Receipts or separate payment documentation are not routinely provided; bank transaction records and the original invoice serve as proof of payment.

3. MID-YEAR ENROLMENT

For students entering ISE after the start of the academic year, school fees are calculated on a pro-rata basis from the student's official start date. The total amount, number of instalments, and specific payment schedule will be detailed on the customized invoice issued upon enrollment.

4. WITHDRAWAL POLICY AND REFUNDS

4.1 Required Withdrawal Notice

To withdraw a student from ISE during or at the end of the school year, parents/guardians must submit the official [Withdrawal Form](#) at least **two (2) weeks prior** to the student's final day of attendance. Completed forms must be emailed to:

- **Primary Department:** primary.admissions@isecampus.nl
- **Secondary Department:** secondary.admissions@isecampus.nl

4.2 Fee Calculations & Exceptions

- **Mid-Year Departure:** School fees will be calculated pro-rata up to the student's official last day of attendance. Any overpaid school fees will be refunded accordingly.
- **End-of-Year Exception:** If a student withdraws within the final two (2) weeks of the official school year, no fees or tuition adjustments will be refunded.
- **Unannounced Departure:** Failure to formally submit the official Withdrawal Form will result in ongoing school fee charges, and the Secondary Security Deposit (€ 500) will be forfeited.

5. LATE PAYMENT, DEFAULT, AND DEREGISTRATION (applicable to the Primary and Secondary International Departments only)

5.1 Notice of Default and Extrajudicial Collection Costs

If payment is not received by the specified due date, the debtor is in default.

1. **Courtesy & Statutory Notice:** The school will issue a courtesy reminder, followed—if necessary—by a statutory 14-day reminder notice pursuant to rules and regulations of the Dutch Civil Code.
2. **Collection Costs & Interest:** If payment remains outstanding fourteen (14) calendar days following the receipt of the 14-day notice, the account will be transferred to a debt collection agency. The debtor will be held liable for all extrajudicial collection costs (*buitengerechtelijke incassokosten*) under the Dutch Collection Costs Decree (*BIK*), as well as statutory interest (*wettelijke rente*) calculated from the default date.

5.2 Cancellation of Registration (Deregistration)

If school fees remain unpaid following formal notices, the Executive Board and Director of ISE reserve the right—where legally permitted—to cancel the registration of the student.

- Written notice of intent to deregister will be served to the parent/guardian.
- The deregistration will take effect sixty (60) calendar days after written notice is served if the outstanding balance remains unsettled. This 60-day period allows parents time to arrange alternative education for the child.

5.3 Re-enrolment Condition

Re-enrolment for any subsequent academic year is strictly conditional upon all financial obligations from previous school years being settled in full.

6. APPLICABLE LAW AND DISPUTE RESOLUTION

1. **Amicable Resolution:** Parties shall make every effort to settle any differences of opinion or disputes amicably.
2. **Governing Law:** All agreements, terms, and disputes arising out of or related to school fee payments are governed exclusively by Dutch law.
3. **Jurisdiction:** If a dispute cannot be resolved amicably, it shall be submitted exclusively to the jurisdiction of the competent court in the Netherlands.
